Additionally, launched in 2016, the ZED scheme soared to new heights crossing 1.5 lakh+ certifications, an indicator that India is eagerly embracing sustainable practices in manufacturing. Sarpanch Samvaad, QCI's grassroots initiative also achieved a milestone with 10,000 sarpanchs registered

We've celebrated significant milestones this quarter. NABL successfully underwent peer evaluation for continuation of APAC/ILAC Mutual Recognition Arrangement signatory status. NABCB has started undergoing APAC peer evaluation by a team of 9 evaluators from APAC region. It also granted the first accreditation for FAMI-QS - an international certification scheme for feed specialty ingredients. NABET signed MoUs with civil society organisations in Nashik for quality upgradation & assessment of schools in Nashik city, and with Dental Council of India & Nursing Council of India for assessment & rating of dental and nursing colleges respectively. NABH expanded its scale across all its programmes & schemes. NBQP launched the Quality Bharat Mission, with the aim to drive quality consciousness and improve quality well-being of citizens with a special focus on engaging the youth through the Youth for Quality Bharat Festival (YQBF).

Further, a DigiReady certification programme was launched for helping small merchants onboard on Open Network for Digital Commerce. We graduated the first batch of 'Gunvatta Gurukul', a program equipping young professionals with skills in public policy and project management. We're also proud to have crossed 1,50,000 certifications under the 'Zero Defect Zero Effect' (ZED) scheme, which ensures Zero Defect manufacturing with minimal environmental impact. Our 'Sarpanch Samvaad' initiative has successfully engaged over 500 village sarpanchs in Varanasi, emphasizing sustainable rural development and quality enhancement at the grassroots level. The Training & Capacity Building Cell conducted 36+ training programmes on various subjects of quality & development under missions of government. It also partnered with bodies such as SADC - S. Africa, PTB Germany, AERSSC Nepal etc for its engagements.







NABL recognition scheme for temporary site laboratories testing Aggregates and Concrete in building projects

National Accreditation Board for Testing and Calibration Laboratories (NABL) has launched the recognition scheme for temporary site laboratories testing Aggregates and Concrete in building projects.

In civil engineering endeavours, the need for on-site testing facilities to assess the basic building materials such as fine aggregates, coarse aggregates, and concrete cubes in imperative, especially in the projects exceeding 50,000 square feet.

To ensure the quality standards and competency of temporary site testing laboratories. NABL's recognition scheme is tailor made specifically for these facilities. This scheme is designed to instill trust in the test results and reports generated by temporary site testing laboratories, a crucial aspect of maintaining the quality of materials used in construction projects. Notably, this scheme applies solely to temporary site testing facilities only, with mobile testing units currently excluded. This scheme is voluntary and an independent quality

assurance scheme, which is not covered under APAC & ILAC MRA.

The competency of temporary site testing laboratories will be assessed through on-site assessment (including test witnessing), participation in proficiency testing programs (PT), and adherence to predefined criteria set by NABL.

NABL recognition for temporary site testing laboratories will be granted for the duration of the project (however, maximum of 5 years), commencing from the issuance of the commencement certificate by the relevant authority and concluding upon obtaining the occupancy certificate.

NABL is having following surveillance mechanisms for temporary site testing laboratories:

- On-site surveillance every 10 to 12 months.
- For projects of shorter duration, surveillance will be conducted every 6 months.

Unannounced assessments may also take place during the recognition period to ensure ongoing compliance.

जल प्रकृति द्वारा प्रदत्त एक बहमूल्य उपहार और जीवन का आधार है। धरती पर जीवन की निरंतरता के लिए जल अनिवार्य तत्व है। घरेलू उपयोग के अलावा कृषि, उद्योग सहित कई अन्य कार्यों के लिए पानी आवश्यक है। लेकिन वर्तमान परिदृश्य में बढती जनसंख्या, जल प्रदूषण और जलवायु परिवर्तन के कारण पानी की उपलब्धता वैश्विक स्तर पर कम हो रही है। धरती पर पानी की कमी एक गंभीर समस्या बनती जा रही है। भारत में पीने योग्य जल की स्थिति जटिल और बहुआयामी है। उपलब्धता, गुणवत्ता और उपयोगिता के मामले में कई चुनौतियां हैं। भारत में पानी की भौगोलिक और मौसमी उपलब्धता में भारी असमानता है। कुछ क्षेत्रों में पानी प्रचुर मात्रा में उपलब्ध है, जबकि कई क्षेत्रों में पानी की भारी कमी है। जल संरक्षण के प्रति उदासीनता. वर्षा जल का अपव्यय और भूजल का अत्यधिक दोहन, पानी की उपलब्धता को कम करते हैं। औद्योगिक और घरेलू अपशिष्ट जल, कृषि में रसायनों के बढ़ते प्रयोग और अन्य प्रदूषकों से जल स्रोतों का दूषित होना पेय जल के संकट को बढाता है। जल स्रोतों- जैसे नदियों और कुओं में बैक्टीरिया, वायरस और अन्य हानिकारक रसायनों की उपस्थिति, पानी की गुणवत्ता को खराब करती है। ग्रामीण और शहरी इलाकों में कई बार प्रदूषित पानी की वजह से जलजनित बीमारियों का खतरा उत्पन्न होता है ।

विशेषज्ञों के अनुसार, भारत में भूमिगत जल स्तर में प्रतिवर्ष कमी हो रही है। देश में एक वर्ष में उपयोग किए जा सकने वाले जल की शुद्ध मात्रा १,१२१ बिलियन क्यूबिक मीटर (बीसीएम) अन्मानित है। जल संसाधन विभाग के अनुसार, जल की कुल मांग वर्ष २०२५ में १,०९३ बिलियन क्यूबिक मीटर (बीसीएम) और वर्ष २०५० में १,४४७ बिलियन क्यूबिक मीटर (बीसीएम) तक पहुंच सकती है जो देश की विशाल जनसंख्या की जरूतों को देखते हुए चिंता का विषय है। ऐसे में जल संरक्षण और प्रबंधन अत्यंत महत्वपूर्ण है।

जल प्रबंधन, जल संसाधनों का कशल और स्थायी उपयोग सुनिश्चित करने के लिए योजना, विकास, वितरण और उपयोग की एक व्यापक प्रणाली है। इसका उद्देश्य जल संकट को कम करना, विभिन्न उपयोगों के लिए

का दीर्घकालिक उपयोग सुनिश्चित करना है। केन्द्र सरकार कैच द रेन, जल जीवन मिशन, परंपरागत जल संरचनाओं का कायाकल्प, जल संचयन आदि अभियानों के माध्यम से जल संरक्षण और प्रबंधन के महत्वपूर्ण प्रयास कर रही है।

भारत में जल प्रबंधन की आवश्यकता

पानी की उपलब्धता और जल संसाधनों

भारत दुनिया का सबसे अधिक आबादी वाला देश है, बढ़ती जनसंख्या के कारण जल की मांग में निरंतर वृद्धि हो रही है, जिसके परिणामस्वरूप जल संसाधनों पर दबाव बढता जा रहा है। जलवायु परिवर्तन के कारण भारत में वर्षा के पैटर्न में बदलाव आया है, जिससे देश के कुछ क्षेत्रों में बाढ़ तो कहीं सूखे जैसे हालात बन जाते हैं। प्रदूषित जल मानव स्वास्थ्य और पर्यावरण के लिए हानिकारक है। औद्योगिक और घरेलू अपशिष्टों के कारण जल प्रदूषण एक बड़ी चुनौती बनता जा रहा है। भारत में कृषि क्षेत्र में जल का अत्यधिक उपयोग होता है और उचित प्रबंधन नहीं होने के कारण सिंचाई के लिए इस्तेमाल होने वाले पानी का एक बडा हिस्सा बबदि हो जाता है। भारत में जल संसाधनों का समुचित प्रबंधन न होने और विभिन्न जल संसाधनों के बीच समन्वय की कमी के परिणामस्वरूप जल का अपव्यय होता है। इसलिए बेहतर जल प्रबंधन जरूरी है।

जल प्रबंधन के तरीके

- छतों से वर्षा जल को टैंक में एकत्रित करना।
- तालाबों, झीलों और बांधों में वर्षा जल का भंडारण।
- नल बंद करके बश करना और शेविंग करना।
- स्नान करते समय पानी व्यर्थ न करना।
- कपडे और बर्तन धोते समय कम पानी का उपयोग करना।
- नलों से टपकते पानी को रोकने के लिए उन्हें तुरंत ठीक करना।
- घरेलू अपशिष्ट जल को ट्रीट करके बागवानी और अन्य गैर-पीने योग्य कार्यों के लिए उपयोग करना।
- उद्योगों में अपशिष्ट जल को पुन: उपयोग करना।
- डिप सिंचाई, स्प्रिंकलर सिंचाई और अन्य जल-कुशल सिंचाई तकनीकों का उपयोग करना।
- ऐसी फसलों का चुनाव करना जिनमें कम पानी की आवश्यकता होती है।
- घरेलु और औद्योगिक अपशिष्ट जल को नदियों और अन्य जल स्रोतों में नहीं डालना।
- रसायनों और कीटनाशकों का अत्यधिक उपयोग न करना।
- लोगों को जल संरक्षण के महत्व के बारे में शिक्षित और जागरूक करना।
- जल संरक्षण के क्षेत्र में कार्य करने वाले लोगों को प्रोत्साहित और पुरस्कृत करना।



- जल संरक्षण और प्रबंधन के लिए नीतियां और नियम बनाना।
- जल संरक्षण परियोजनाओं के लिए धन उपलब्ध कराना।
- वृक्षारोपण और अन्य उपायों द्वारा जलग्रहण क्षेत्रों की रक्षा करना।
- जलग्रहण क्षेत्रों में जल संरक्षण के लिए कार्यक्रमों का संचालन करना।
- जल उपयोगकतओं के बीच जल संसाधनों का न्यायसंगत वितरण सनिश्चित करना।
- जल संसाधनों के एकीकृत प्रबंधन के लिए योजनाएं बनाना।

- यह जल संकट से बचने और जलवायु परिवर्तन के दुष्प्रभावों को कम करने में मदद करता है।


निष्कर्ष

Quality Interventions in 128 schools under Pimpri Chinchwad Municipal **Corporation (PCMC)**

After completing teaching-learning process observations for 1200+ teachers and baseline assessment of 41,987 students in 128 schools, these students were categorized under A, B, C and D categories, with the C and D categories indicating low-performing students. Further, the root cause assessments were conducted for around 6361 students falling in the borderline C category and D category to identify the underlying factors contributing to the performance decline of these students. Detailed root cause analysis reports have also been shared with the schools, highlighting inferences and probable reasons for the low performance of students

Out of these 97 GoEs, 38 GoEs have been approved by PMAC. The process for selecting a Lean Consultant to handhold these approved 38 GoEs is in process.

Through its flagship program, "2+2 Mode of Partnership", IGSTC intends to catalyse innovation-centric R&D projects by synergising the strength of research/ academic institutions and public/private industries in India and Germany.

QCI Experts visited 6 different Indian industries located at various places in the country for their physical assessment of the R&D capabilities.

Outcome

• A comprehensive final report has been crafted and submitted to IGSTC. The IGSTC team has accepted and appreciated the report.

Impact Assessment

Impact Assessment Study of CeNSE

The Centre for Nano Science and Engineering (CeNSE) is an interdisciplinary research centre at the Indian Institute of Science (IISc) in Bangalore, India. It conducts research in diverse areas, including nanoelectronics, nanophotonics, nanomaterials, nanobiotechnology, and nanofabrication techniques. The centre has state-of-the-art facilities and laboratories for the characterization, fabrication, and manipulation of nanomaterials and nanostructures.

A team of QCI experts visited the Indian Institute of Science, Bangalore, from January 29th to February 1st to assess the Centre physically. The division carried out around 80 virtual and physical assessments.

Outcome

Audit of Haryana State Private Universities

The Haryana Government has accepted the proposal to conduct audits of 24 state-private universities. The division has started working in this area.


NABH is ISQua approved and accepted internationally, at par with the best in the world.

Digital Health Initiatives

In line with making our country digitally empowered. NABH has announced digital health initiatives with the intent of strengthening digital health infrastructure of the country & bringing quality in the digital heath systems. NABH will soon be launching digital health standards and these will be first-of-its- kind in the country. Under this initiative NABH has entered into an MoU with National Health Authority (NHA) and has offered to support Ayushman Bharat Digital Mission (ABDM) launched by Government of India in year 2021. NABH is committed to creating awareness about components of ABDM amongst accredited/certified partner healthcare organizations.

NABH has also conducted assessments of 12 healthcare solutions for certifying ABDM









compliant health solutions upon receiving request from ABDM – NHA. NABH is in the process of developing certification scheme for healthcare solutions including Hospital Management Information System (HMIS), Laboratory Management Information System (LMIS) and clinics.

Outcome

India's first ever Digital Health Standards to ensure the safe & secure use of digital health solutions and to improve the overall clinical care & quality ecosystem in the country. These standards are intended to be used for the assessment of digital processes implemented by the organization for providing patient care services.

NABH standards for EMR-HIS vendors

Multiple meetings with PwC have been conducted and the first draft would be ready by April/May 2024.

Outcome

The EMR-HIS standards will be first-of-its-kind in Digital Health

NABH Digital Transformation

The roadmap for Digital transformation plan has been created. The initial discussion has been carried out internally and next steps identified.

Outcome

When accreditation management is digitally transformed, the resulting alignment of actions offer ample opportunities to increase process efficiency, establish sustainable, high-quality stakeholder's data management.

New and revised standards of various NABH programs

NABH launched 3rd edition accreditation standards for SHCO to provide framework for quality of care for patients and quality improvement for small healthcare organizations. These revised standards help build a quality culture at all level and across all the functions of SHCO.

JANUARY - MARCH 2024

NABH launched the 3rd edition of NABH Dental Health Service Providers accreditation standards and the 1st edition of NABH Entry Level Certification standards for Dental Facilities (upto 8 chairs). The entry level dental standards is a small but a sure step for quality dental services in the rural and tier-3,4 cities to accomplish the mission of taking quality healthcare to the last in the line.

Outcome

In collaboration with CII, the accreditation standards for Care Homes have been developed and the pilot assessments as per the draft standards have been completed. The standards shall be released very soon.

Standards for Standalone Dialysis Centers in collaboration with NATHealth, standards for Standalone Dermatology and Cosmetology Centers in collaboration with Indian Association of Dermatologists, Venereologists and Leprologists (IADVL) and standards for Stroke care centers in collaboration with World Stroke Organization (WSO) have also been prepared.

Certification of Ayushman Bharat Digital Mission (ABDM) Health Solutions

In consultation with National Health Authority (NHA), NABH has conducted pilot assessments for ABDM compliant healthcare solutions. Development of certification scheme for HMIS, LMIS & Clinics is underway and will soon be announced by NABH.

Outcome

The extensive project in traditional medicine will open ways for a transformation in quality and patient safety in specific traditional and integrated medicine domains.

Inspection of National Commission of Homoeopathy (NCH)

Inspections of 3 Homoeopathic colleges & hospitals as per the requirements provided by NCH have been completed by NABH on pilot basis. The reports have been submitted to NCH. NCH has shown keen interest in extending this activity to all existing 247 Homoeopathic colleges in the country.

Phase 1 completed: 96 Homoeopathic Medical College & Hospital were inspected during phase 1. Phase 2 is in pipeline.

Outcome

The extensive project in Homeopathy colleges will open ways for a transformation in quality and patient safety in Homeopathic education and traditional medicine domains.

Heal in India - Role of NABH in Medical Value travel

The Indian Healthcare Ecosystem is delivering world-class medical care/treatment across the healthcare spectrum ranging from Modern Medicine, Ayurveda, Yoga, and other Traditional Systems of Healthcare.

NABH is working with Ministry of Health & Family Welfare for the promotion of Medical tourism in India. NABH already has a well curated Empanelment program with a validity of two years for all the Medical Value Travel Facilitator (MVTF) since 2016.

Outcome

The empanelment criteria provide framework for quality of care for patients and quality improvement for medical value travel facilitators. It helps build a quality culture at all level and across all the functions of MVTF. A full day one of its kind in India, technical training program for the Empanelment criteria has also been created for ease of the MVTF. NABH continues to evolve in this space as per the best practices across the globe.

This project shall guide action towards Sarpanchs and healthcare workers to lead and undertake activities for improved access and service delivery at their village level and shall bring a great transformation and revolution in the primary healthcare system of the country.

Becoming the Best Ever in Laboratory Accreditation

NABL is an accreditation body, with its accreditation system established in accordance with ISO/ IEC 17011. "Conformity Assessment – Requirements for Accreditation bodies accrediting conformity assessment bodies."

Recognition scheme for Temporary Site **Laboratories Testing Aggregates and Concrete in Building Projects.**

NABL has launched a recognition scheme for such laboratories.

Outcome

This recognition scheme will give confidence in the test result/report issued by temporary site testing laboratories, which is necessary to ensure the quality of materials used for building construction. The scheme applies only to temporary site testing facilities. This scheme is voluntary and an independent quality assurance scheme, which is not covered under APAC & ILAC MRA.

The awareness program is planned in phases starting from March 2024 wherein 6 cities in India will be covered in 1st phase.





- 2. Excellence in Operation & Maintenance recognizes projects with the swift and smooth execution of maintenance work(s), inspections, and unparalleled quality in riding experience.
- 3. Excellence in Highway Safety acknowledges commendable work done to reduce road casualties and establish preventative safety measures, safety signages, road markings, and emergency response services.
- 4. Innovation or Outstanding Work in Challenging Conditions focuses on significant achievement in devising or adapting a new technology or design in construction that enhances the quality, timeliness, cost effectiveness, safety and/or efficiency in the road development project(s) in addition to the special measures undertaken to develop highway infrastructure in a challenging environment (tough natural terrain, complex urban landscape, challenging climate or conflict zones)






